Conditions of participation – Nordicfurdance

The conditions of participation are written in German and English. In case of doubt, the German version shall prevail. This document contains three pages.

By taking part in the "Nordicfurdance" event and/or entering the event area, the participant confirms that he or she has read, understood and accepted these Terms and Conditions of Participation. The conditions of participation are publicly posted at the entrance and can be viewed by everyone on the website (https://www.nordicfurdance.de).

The aim of the conditions of participation is to prevent endangerment or damage to/at persons and objects and to guarantee a trouble-free course of the event.

General:

All participants of the event "Nordicfurdance" must have reached legal majority in Germany at the beginning of the event. Participation under the age of 18 is excluded, even with the consent of the legal guardians.

The participant is responsible for himself/herself, his/her own actions, activities and property.

Photos and video recordings made at the event can be used by the VzFaK e.V. (organizer) (website/social media) if the photographer gives his consent.

The use is exclusively for non-commercial purposes. An objection is possible if the depicted and reporting person is one and the same. The objection must be sent to info@anthro-kunst.de

If personal injury or damage to property occurs, the organizer or the security service must be informed immediately.

It goes without saying that we treat all participants with respect.

Each participant shall act in such a way that no one else is harmed, endangered or more than is unavoidably obstructed or harassed under these circumstances. Everyone must comply with the orders of the law enforcement agencies, in particular the police, the fire brigade and the event director. Announcements must always be obeyed and the instructions must be followed.

The consumption of drinks brought along during the event is not allowed on the whole area.

In the event of excessive alcohol abuse and resulting insanity on the part of the participant, the organizer is obliged to prohibit the serving of alcoholic beverages to the participant concerned or to exclude the participant from the event or to refuse admission.

Liability:

The organizer excludes liability for items brought along and is not responsible for their safe custody.

Entering the plant is at your own risk. The organizer is not liable for personal injury and material damage caused by third parties.

The liability of the organizer and his vicarious agents and assistants, of whatever kind, is limited to intent and gross negligence in the case of all kinds of damage.

Except in the case of damage to life, body or health as well as other damages in the case of intentional or grossly negligent acts, the liability of the organizer is limited to compensation for foreseeable, contract-typical damage.

Due to increased volume and the use of lighting effects, there is a risk of possible damage to hearing and health at the event. The operator is only liable for hearing and health damage within the framework of legal liability if he and his vicarious agent can be charged with intent or gross negligence.

In case of food intolerances, the participant is obliged to inform himself about problematic ingredients. Allergens are marked on appropriate displays or, in case of doubt, can be requested from the staff.

It's forbidden:

- to disrupt the event;
- use escape stairwells and specially marked emergency exits, unless there is a request for evacuation or an immediate danger to life and body;
- to light or shoot down pyrotechnics;
- to mark, paint or paste on buildings, facilities or paths;
- restrict or impair escape routes;
- block or impede access to emergency exits, fire extinguishers or electrical distributors;
- to consume substances that are classified as illegal narcotics in Germany;
- Carry and use the following items with you:
 - Weapons of any kind and objects intentionally used as weapons;
 - Gas spray bottles, corrosive or colouring substances or pressure vessels for flammable or harmful gases, except for commercial pocket lighters and disinfectants for costumes;
 - Pyrotechnics;
 - Mechanically or electrically operated noise instruments (e. g. megaphone, gas pressure fanfares);
 - Laser pointer;
 - Drugs within the meaning of the German Narcotics Act (BtMG);
 - Animals of any kind.

The security service can extend the list without restriction, after weighing up the potential danger for the participants and their own discretion.

Coronavirus Disease (COVID-19)

Due to the current ongoing pandemic, it is mandatory to take protective actions. The organizer acts according to the regulation of the city of Hamburg, as well as the currently valid version of the Infection Protection Act - IfSG.

Despite all actions taken, an infection of persons by the coronavirus at the event cannot be excluded.

Each person attending the event acknowledges the risk and possible consequences. The organizer excludes any liability on his part.

Participation in the event requires a verifiable, complete, immunization against COVID-19 (Coronavirus SARS-CoV-2) and a test certificate. The test must be no more than 24 hours old at the time of admission. This follows the two-G plus admission model with the exception that a booster vaccination does not replace the test. The test must have been administered by an official testing agency.

Indoor masking is not currently mandatory, but may be mandated at any time due to changes in the situation.

Closing sentence:

Violations of the conditions of participation can lead to an immediate exclusion or in serious cases to a permanent exclusion from the event. Crimes will be reported.

The conditions of participation can be changed by the organizer at any time and without giving reasons. A new edition of the Conditions of Participation replaces any previous edition and thus invalidates it.
